## **BCA SEALS GZIRA CONSTRUCTION SITE AFTER STOPPING WORKS BEYOND LEGAL TIMES**

The Building and Construction Agency (BCA) has sealed a construction site in Triq Manuel De Vilhena in Gzira that is not compliant with regulations.

BCA has requested the Executive Police to initiate criminal proceedings against the Developer, Site Manager and Periti in charge of the project in consequence to the breach of the obligation to submit the required documents prior to the commencement of works, incorrect information on the Site Notice and due to works being carried out beyond permitted hours.

The BCA stated that besides the missing documentation, there was no hoarding covering the site, and on the 9<sup>th</sup> of April BCA personnel went on site to stop works since they continued beyond the stipulated legal times.
